- 1. Issue notice.
- 2. Mr. Mukesh Kumar Maroria, learned counsel, accepts notice on behalf of the respondents. Service upon the respondents is, accordingly, waived off.
- 3. Heard learned counsel for the parties.
- 4. The prayer in the instant application is to recall the order dated 22.07.2022, whereby SLP(C)No.30333 of 2018, filed by applicant/petitioner, was disposed of along with other lossed of along with other lossed. Innected matters. The order of final disposal is sought to be recalled on the ground that the applicant/petitioner has challenged the constitutional validity of Section 140(3)(iv) of the Central

Goods and Service Tax Act, 2017, which was not the issue that arose for consideration when a batch of SLPs was disposed of on 22.07.2022.

- 5. Learned counsel appearing on behalf of the Revenue fairly submits that he has no objection if the Order dated 22.07.2022 is recalled qua the applicant/petitioner.
- In this view of the matter, M.A.No.108 of 2023 is allowed; the Order dated 22.07.2022, disposing of SLP(C)No.30333 of 2018, is recalled and the said SLP is restored to its original number and file. Consequently, IA No.194090/2022 stands disposed of.
